

 - An addict noted that conversations such as this are appropriate at the Area level, but not as topics for home groups meetings.
 - o Several addicts noted the autonomy of the groups and the importance of group conscience.
 - o An addict noted that when people are high at meetings they need love, not confronted, ridiculed or ostracised.
 - o Several addicts noted that those pursuing MAT are absolutely welcome in the rooms of Narcotics Anonymous, and every effort should be made to make them feel welcome. We ought not chase anyone away from the rooms of NA, and with a program of attraction they may come around to the realization that they too can be abstinent from all drugs. The only requirement for membership is a desire to stop using.
 - An addict offered a final note that he came to the rooms a drug addict, definitely didn't know how to stay clean for quite some time while attending meetings and being of service, and the love of the rooms gave him a new way of life!
